BECOMING A MEMBER

You may become a member of the Korosy Heritage Club simply by notifying us that you have named HVA as a beneficiary in your will, estate plan or on an account.

PLANNED GIVING CAN INCLUDE

- **Bequest in a Will or Living Trust:** the easiest and most common way of making a planned gift is through a bequest in your will. You can designate a specific amount of money, a percentage of your estate, or a specific asset. HVA could also be named as a contingent beneficiary.
- **Beneficiary** of a specific account, such as a bank account, money market account or IRA.
- **Life Income Gifts:** Gifts such as a charitable gift annuity or a charitable remainder trust. Upon your passing, HVA receives the gift. Life income gifts generally reduce or eliminate certain taxes today and guarantee an income for life.
- **Life Insurance:** Life insurance can be used to make a sizeable gift to HVA. For example, you can purchase a new policy and make HVA the owner and beneficiary of the policy or an existing policy you no longer need.
- **A Life Estate:** You can deed your home, vacation property, or condominium to HVA and retain the right to live in the property and/or receive income from the property for as long as you or your beneficiaries live.

Check with your financial and legal advisors before making a gift.
